# **October Is National Disability Employment Awareness Month**

Murray Ridge Center is once again pleased to participate in **National Disability Employment Awareness Month** — an annual awareness campaign that takes place each October. We're proud to salute the nearly 1,000 Lorain County citizens with developmental disabilities who are part of the local workforce, and the more than 100 local businesses that provide jobs for these individuals. Through our three Opportunity and Vocational Centers (OVCs) and Supported Employment Program, Murray Ridge Center continues to focus on finding and placing individuals in positions where they can grow and excel in today's competitive job market.

Check out the stories below for just a couple of recent examples of how our program participants are making a huge difference in our local business community!



**Saundra Kilgore** – Saundra has attended our Day Program at the Oberlin Opportunity/Vocational Center (OOVC) since 2014. She has participated in training at community-based work sites at Oberlin College (dishwashing/lobby attendant duties), First Church in Oberlin (custodial duties), and Splash Zone (janitorial duties). She was employed by Oberlin College Dining Services in March of this year. Saundra received assistance from Murray Ridge with obtaining the job, and support from a job coach to master her duties on the job. Murray Ridge now provides her with ongoing follow-along supports, and with transportation to and from work. When asked about her job at Oberlin College, Saundra simply says "I love it!"

**Bryon Ragin** – Bryon also attends the OOVC. He participated in training at the following group employment work sites: Oberlin College (dishwashing/lobby attendant duties) and First Church in Oberlin (custodial duties). In August of this year, Bryon was employed by Pizza Hut in Oberlin as a dish washer.

Bryon's family assists him with transportation to and from work. He received assistance from Murray Ridge with obtaining the job and job coaching to learn his employer's expectations. We now provide him with ongoing follow-along supports.

Staff reports that Bryon is doing well at Pizza Hut. He has perfect attendance and his managers like him. When asked about his job, Bryon says he likes it and says his co-workers are 'nice.'

# **October is Down Syndrome Awareness Month**



Did you know that each year in the United States, about 6,000 babies are born with Down syndrome? That's about one in every 700 babies born. Down syndrome is the most commonly occurring chromosomal condition, and it is estimated that today in the United States there are more than 400,000 people living with Down syndrome. Since the 1980s, American families touched by Down syndrome have observed October as National Down Syndrome Awareness Month: a time to recognize that those born with Down syndrome can indeed live happy, long and productive lives. ## **Q & A Corner**

As the system for serving people with developmental disabilities evolves, those eligible for services and their family members may have many questions. Below are answers to some questions that have arisen.



#### Supt. Amber Fisher

Q. Why have many county boards of developmental disabilities (DD) stopped directly operating Adult Service Programs?

A. The federal Medicaid agency (the Centers for Medicare & Medicaid Services) took the position that it will not be permissible for organizations to provide Medicaid-funded direct services to individuals to whom they also provide "case management" (unless no other certified Medicaid provider is willing to provide the direct services). Service & Support Administration, which is a core function of county boards of DD, is considered case management. Therefore, in 2024 federal funding will no

longer be available for support provided to Medicaid waiver recipients through county board-operated Adult Service Programs.

#### Q. What are the plans for Murray Ridge Adult Services?

A. We are currently in the first year of a 3-year (2019-2021) strategic plan. That plan clearly reflects the intent of the Lorain County Board of DD to operate Murray Ridge Adult Services throughout the timeframe covered by the plan. Prior to the expiration of the plan, determinations will be made about what will occur during the following 3-year period, and you will be kept informed as related considerations/determinations are made.

# Q. In late 2018, Murray Ridge Adult Services 'shut the front door.' Remind me what this means, and why this occurred.

A. This means that people who are enrolled on Medicaid waivers can not subsequently be enrolled (or re-enrolled) in the Murray Ridge Adult Service Program. This decision was made because the Ohio Department of DD made it very clear that this was an expectation, and that our accreditation would be adversely affected if we did not take this action.

# Q. How will Murray Ridge be involved with my day/vocational support if I attend an Adult Service Program operated by a different provider?

A. Through our Service and Support Administration (SSA) Department we will coordinate your adult services by, among other things, assisting you to identify in your person-centered plan the supports that you need and desire; your SSA will also monitor your services, and help you to keep your plan updated. Additionally, your SSA will authorize payment for Medicaid-funded adult services and, in most cases, Murray Ridge will be responsible for covering the non-federal share of the cost of these services. Soon, the SSA Department will begin enrolling on Medicaid waivers those on the waiting list who have 'Current Needs;' individuals who require "waiver funding for adult day services or employment-related supports ..." (see Ohio Administrative Code: 5123-9-04) are considered to have a "Current Need." (These enrollments are not allowed to begin until everyone who was on the waiting list before 09/01/2018 has been assessed in accordance with OAC 5123-9-04 - see the June edition of the Murray Ridge Courier for more information on this top-ic.)

# Q. If I am actively enrolled in the Murray Ridge Adult Program (i.e. attending an OVC or receiving assistance through the Murray Ridge Supported Employment Department) and become (newly) enrolled on a Medicaid waiver, may I continue at this time to receive support through Murray Ridge Adult Services?

A. Yes; however, you will be encouraged to explore your options.

Throughout the year, Murray Ridge School teachers in need of a little extra financial support for class projects make use of a program called **Donors Choose** — a civic crowd funding platform founded in 2000 which allows individuals to donate online directly to public classroom projects.

Teacher **Kristin Dickerhoff** was able to obtain new aprons and matching chef hats (pictured top right, **Wyatt Bathurst**) for students to look the part as they used their new mixing bowls, mixing spoons, and bakeware for a kitchen skills curriculum. **Julie Maurer's** classroom at Murray Ridge School recently received all new markers and file organizers, pencil boxes and markers, as well as new file trays to help students keep their papers organized and easily accessible! ### **BOARD ROOM BRIEFING**

### The Lorain County Board of DD convened at 6:30 p.m. on September 30, 2018:

Superintendent Fisher provided updates on a number of State Biennium Budget provisions that impact the Developmental Disabilities (DD) system; these included: funding to increase the rate for certain Medicaid waiver services in order to support increases to wages of direct support professionals who deliver these services, Medicaid Reserve Funds, Budget Commission due process protections, five-year financial forecast requirements, specific requirements for county boards of DD to make available information on and notify those seeking residential services about Intermediate Care Facilities for People with Intellectual Disabilities (ICFIIDs), and Summary Suspension (of certification for a provider to deliver services at a particular site) capability of the Ohio Department of DD for the protection of health and safety. The Board appointed Board Member Rebecca Cornman as delegate and Dr. Fisher as alternate to the 2019 delegate assembly of the Ohio Association of County Boards Serving People with DD. Board President Bob Gajdos congratulated ICFIID Administrator Christine Ash and her team on the perfect survey at the Meister Road Home (a residential facility operated by the Lorain County Board of DD).
